

Online Casting Call for Curiosity Cove
Terms and Conditions

1. General

- 1.1. These terms and conditions ("**T&Cs**") apply to the Casting Call (as hereinafter defined) organised by the Mandai Wildlife Group (or "**MWG**", both as defined in the Parks Rules and Conditions).
- 1.2. In these T&Cs, "we", "us", or "our" refers to MWG and "you" and "your" refers to the Parent /Guardian (as hereinafter defined) on behalf of the Participant (as hereinafter defined).
- 1.3. By submitting to us an Audition Video (as hereinafter defined), you hereby agree and acknowledge that you have read, understood, and accept these T&Cs, for and on behalf of the Participant. You undertake to inform and explain these T&Cs to the Participant and confirm that the Participant understands these T&Cs.
- 1.4. We reserve the right to make changes to these T&Cs from time to time and without prior notice to you.

2. Definitions

- 2.1. "**Audition Video**" means a digital video clip submitted to us featuring the Participant for the Casting Call.
- 2.2. "**Casting Call**" means the casting call to be a Curious Kid at Curiosity Cove.
- 2.3. "**Image**" means the Participant's name, voice, images, appearance, biography, and/or likeness.
- 2.4. "**Media**" means all photographs, films, videotapes that are displayed, edited, used, reproduced, and/or published that contain the Participant's Image.
- 2.5. "**Parent / Guardian**" means the individual (a) reading, understanding, and accepting these terms and conditions on behalf of the Participant, and (b) confirming they are the legal parent or guardian of the Participant.

- 2.7. "**Parks Rules and Conditions**" means MWG's Parks Rules and Conditions found at: <https://www.mandai.com/en/plan-your-visit/parks-rules-conditions.html>.
- 2.8. "**Participant**" means a child between the age of 6 and 12 years old (as at the time of filming of the Audition Video), who is a Resident (as defined in our Park Tickets Terms and Conditions), participating in the Casting Call.
- 2.9. "**Production Dates**" means a maximum of three (3) separate production dates within the period of December 2025 to February 2026, or such other period as determined by MWG.
- 2.10. "**Submission Period**" means 12 November 2025 to 14 December 2025 (both dates inclusive).
- 2.11. "**Successful Participant**" means a Participant who has been selected by MWG to be a Curious Kid at Curiosity Cove.

3. Casting Call Timeline

- 3.1. To audition for the Casting Call, Audition Videos must be submitted to us during the Submission Period by sending the Audition Video via the submission form link here: <https://go.mandai.com/callforcuriouskids>. Any Audition Videos received after the Submission Period will not be considered.
- 3.2. We reserve the right to amend the Submission Period at any time, in our sole and absolute discretion.
- 3.3. Successful Participants will be contacted, via their Parent/Guardian, through the email address and/or contact number provided to us when submitting the Audition Video. Please note that Participants who have not been selected to be a Curious Kid will not be notified.

4. Audition Video Requirements and Selection Process

4.1. Contents of Audition Video

- 4.1.1. The Audition Video must have a duration of approximately thirty (30) seconds.
- 4.1.2. The Audition Video must feature the Participant (a) sharing about their favourite animal, (b) explaining why the animal is their favourite, and (c) stating what they are curious about or interested to find out more about their chosen animal.
- 4.1.3. We do not assume any responsibility for any Audition Video that is incomplete, incomprehensible, corrupted, misdirected, lost, delayed, or unable to be submitted due to technical or transmission failures of any kind or any other reason.

4.2. Selection

- 4.2.1. The submission of an Audition Video does not guarantee the Participant's selection as a Successful Participant.
- 4.2.2. Participants will be selected based solely on the artistic and creative merit of their Audition Videos.
- 4.2.3. Selection results of Successful Participants are final and non-negotiable.

5. Parent/Guardian Consent and Supervision

- 5.1. By submitting to us the Audition Video, you hereby confirm the following:
 - 5.1.1. You are the Parent / Guardian of the Participant and have full authority to grant us all permissions and rights herein;
 - 5.1.2. The Participant is a Resident;
 - 5.1.3. If the Participant is selected as a Successful Participant, you agree to remain physically present at all Curious Kids at Curiosity Cove productions on the Production Dates, and shall actively supervise the Participant at all times during each production. We are not responsible for supervising the Successful Participant at any point in time. Supervision of the Successful Participant remains your sole responsibility.
 - 5.1.4. Our selection of a Successful Participant will be determined by the availability of both you and the Successful Participant on the Production Dates. For clarity, the Production Dates will be scheduled mutually between you and us.

6. Intellectual Property

- 6.1. You hereby acknowledge, for and on behalf of the Participant, that full ownership of the intellectual property rights in any of the Media which is recorded, made or produced by the MWG shall vest with MWG exclusively and MWG shall have the exclusive right to licence, use, reproduce, duplicate and/or otherwise exploit the Media without liability to you or the Participant.
- 6.2. You grant us a worldwide, perpetual, royalty-free and non-exclusive licence to use and to authorise others to use, the Participant's Image in the Media.
- 6.3. You warrant that you are the sole owner of the Audition Video that is submitted to us and that your submission of the Audition Video to us does not violate the rights of any third party. You agree to grant us a worldwide, perpetual, royalty-free and exclusive licence for the use of the Audition Video for purposes associated with the assessment of your submission.

7. Non-Employment and Consideration

- 7.1. No Employment
 - 7.1.1. You acknowledge that the Participant's involvement in the (a) Casting Call is purely for the purpose of auditioning to be a Curious Kid at Curiosity Cove, and, (b) if selected as a Successful Participant, subsequent participation in the creation of marketing content as a Curious Kid at Curiosity Cove, is not an offer of employment, contractor status, or an agreement for ongoing financial compensation.
- 7.2. Benefits
 - 7.2.1. Successful Participants will receive from us one (1) non-transferable Friends of Mandai Premium Membership (Family Package: 2 Adults + 1 Child/Teen) for up to 6 years, Ranger Buddies Kit and a starter pack, the contents of which will be determined by us in our sole and absolute discretion.
- 7.3. Expense Exclusions:
 - 7.3.1. We shall not be responsible for covering any costs incurred by you or the Participant related to transportation, parking, accommodation, or meals associated with attending any in-person recording sessions or Production Dates.

8. Personal Data

- 8.1. By submitting to us the Audition Videos, you acknowledge that you have read and understood the MWG Personal Data Protection Policy, which can be accessed via the following link: <https://www.mandai.com/en/saving-wildlife/our-policies/data-protection.html>, and consent to the collection, use and disclosure of the Audition Videos by the Mandai Wildlife Group.

9. Confidentiality

- 9.1. If we provide to you or the Participant with any proprietary information, including scripts, marketing strategies, or unreleased product details, you agree that such information is confidential in nature and will not be disclosed to any third party without our consent in writing.

10. Indemnification and Release of Liability

- 10.1. Save to the extent permitted by law, you and the Participant agree to indemnify and hold us and our directors, officers, employees, agents or contractors (the “**Indemnified Parties**”) harmless from and against all claims, demands, actions, judgements, damages, losses, costs, expenses, penalties or liability of any nature which we / the Indemnified Parties may suffer or incur for any death, injury, accidents, loss, or damages caused by any negligence, act or omission arising from or in connection with the Participant’s participation in the Casting Call.

11. Dispute

- 11.1. In the event of any inconsistency between these T&Cs and any other form of publicity collaterals relating to the Casting Call, these T&Cs shall prevail.
- 11.2. In the event of a dispute arising from or in connection with these T&Cs and/or the Casting Call, our decision on all matters relating to these T&Cs and the Casting Call is final, conclusive, and binding on you and the Participant, and no correspondence or appeals will be entertained.
